**AN ORDINANCE OF THE CITY OF ST. CLAIR, ST. CLAIR COUNTY, MICHIGAN TO ESTABLISH THE MUSEUM HISTORIC DISTRICT PURSUANT TO CHAPTER 14 "BUILDINGS AND BUILDING REGULATIONS," ARTICLE XI "HISTORIC DISTRICTS," SECTION 304(6)(b) OF THE ST. CLAIR CITY CODE.**

**THE CITY OF ST. CLAIR ORDAINS:**

**SECTION 1. ESTABLISHMENT OF MUSEUM HISTORIC DISTRICT PURSUANT TO SECTION 14-304(6)(b) OF THE ST. CLAIR CITY CODE.**

The Museum Historic District is hereby established by adopting Section 14-350 of the St. Clair City Code to read as follows:

**Section 14-350. Establishment of Museum Historic District.**

The boundaries of the Museum Historic District are as shown on the map on file in the office of the City Clerk which is incorporated into and made a part of this chapter, and is comprised of the following described areas:

1. ENTIRE BLOCK BOUNDED N BY TRUMBULL ST, S BY CASS ST, E BY 4TH ST & W BY 5TH ST EXC S 60' OF E 90' THEREOF MAP OF ST CLAIR EXEMPT

Commonly known as 411 Trumbull Street; Parcel ID No. 74-07-049-0040-000

and

2. S 60' OF E 90' OF THE BLOCK BOUNDED N BY TRUMBULL ST, S BY CASS ST, E BY 4TH ST & W BY 5TH ST MAP OF ST CLAIR EXEMPT

Commonly known as 314 S. Fourth Street; Parcel ID No. 74-07-049-0040-100

**SECTION 2. SEVERABILITY.**

This Ordinance and each of the various parts, sections, subsections, sentences, phrases, and clauses hereof are declared to be severable. If any part, section, subsection, sentence, phrase, or clause is determined to be invalid or unenforceable by a court of competent jurisdiction, it is hereby provided that the remainder of the Ordinance shall not be affected thereby and shall remain in full force and effect.

**SECTION 3. REPEAL OF ORDINANCES IN CONFLICT HEREWITH.**

Any and all Ordinances of the City of St. Clair or any parts or provisions thereof, to the extent that they are contrary to or inconsistent with the provisions of the within Ordinance, are hereby expressly repealed.

**SECTION 4. RATIFICATION.**

All other provisions of the code of Ordinances of the City of St. Clair, Michigan except as herein modified or amended are hereby expressly ratified and affirmed.


**SECTION 5. PUBLICATION.**

This Ordinance shall take immediate effect upon publication in accordance with the provisions and requirements of the City Charter of the City of St. Clair.


