## ORDINANCE NO. 2016-04 CITY OF ST. CLAIR COUNTY OF ST. CLAIR, MICHIGAN

AN ORDINANCE OF THE CITY OF ST. CLAIR, ST. CLAIR COUNTY, MICHIGAN TO AMEND ARTICLE 8B "DOWNTOWN REDEVELOPMENT DISTRICT" OF APPENDIX B OF THE CITY'S CODE OF ORDINANCES "ZONING" BY REVISING SECTION 27 "SCHEDULE OF BUILDING USE" AND SECTION 35.1 "DEFINITIONS OF BUILDING AND SITE ELEMENTS."

### THE CITY OF ST. CLAIR ORDAINS:

#### **SECTION 1. AMENDMENT.**

Appendix B, Article 8B of the City Code of Ordinances is hereby amended by

adopting Sections 27 and 35.1 to read as follows:

## **ARTICLE 8B. DOWNTOWN REDEVELOPMENT DISTRICT**

Section 8.27 Schedule of Building Use is amended by adding to the table in the left-hand column entitled "Building" the following two categories "Micro Brewer, Small Wine Maker, and Small Distiller in an Existing Building," and "Micro Brewer, Small Wine Maker, and Small Distiller in a Building Requiring Modifications." The former shall be designated a "Permitted Use" under the column entitled "Riverside Drive" district and the latter shall be designated a "Special Approval Use" under the column entitled "Riverside Drive" district.

**Section 8.35.1 Definitions of Building and Site Elements** is amended by adding between the definitions of *Liner Building* and *Module* the following: *Micro Brewer, Small Wine Maker and Small Distiller*. Any business whose primary purpose is the creation of alcoholic beverages, where such business has been granted a license issued by the State of Michigan Liquor Control Commission for such operation.

# SECTION 2. SEVERABILITY.

This Ordinance and each of the various parts, sections, subsections, sentences, phrases and clauses hereof are hereby declared to be severable. If any part, section, subsection, sentence, phrase or clause is determined to be invalid or unenforceable by a court of competent jurisdiction, it is hereby provided that the remainder of this Ordinance shall not be affected thereby and shall remain in full force and effect.

# SECTION 3. REPEAL OF ORDINANCES IN CONFLICT HEREWITH.

Any and all Ordinances of the City of St. Clair or any parts or provisions thereof, to the extent that they are contrary to or inconsistent with the provisions of the within Ordinance, are hereby expressly repealed.

# SECTION 4. RATIFICATION

All other provisions of the City of St. Clair Zoning Ordinance except as herein modified or amended are hereby expressly ratified and affirmed.

# SECTION 5. PUBLICATION.

This Ordinance shall be published in accordance with the terms, provisions and requirements of the City Charter of the City of St. Clair, Michigan, and in accordance with and to the extent required by the statutes of the State of Michigan.

# SECTION 6. EFFECTIVE DATE OF ORDINANCE.

This Ordinance shall take effect upon publication in accordance with the provisions and requirements of the City Charter of the City of St. Clair.
