RESOLUTION NO. 16-03

A RESOLUTION RECOGNIZING BLUE WATER OFFSHORE RACING ASSOCIATION, INC. AS A “SERVICE ORGANIZATION” AS DEFINED BY PUBLIC ACT 382 OF 1972 AND RECOMMENDING ITS APPROVAL FOR THE PURPOSE OF OBTAINING A CHARITABLE GAMING LICENSE.

A RESOLUTION of the City Council of the City of St. Clair adopted at a regular meeting of said Council held at City Hall located at 547 N. Carney Drive, St. Clair, Michigan, on the 21st day of March, 2016 at 7:00 PM.

WHEREAS, Public Act 382 of 1972, also known as Traxler-McCauley-Law-Bowman Bingo Act, MCL Section 432.101 *et seq.* (“the statute”), authorizes the issuance of charitable gaming licenses to qualified local nonprofit civic organizations that are unaffiliated with state or national organizations; and

WHEREAS, the statute defines such qualified groups as “service organizations” at MCL Section 432.103(k)(ii); and

WHEREAS, the statute requires the local unit of government in which the service organization conducts its principal activities to recognize it as such in furtherance of its application for a charitable gaming license; and

WHEREAS, Blue Water Offshore Racing Association, Inc. is a duly authorized Michigan nonprofit corporation in good standing with a registered corporate office of 157 Cardinal Drive, Marysville, MI 48040-1009; and

WHEREAS, the St. Clair City Council wishes to assist and support Blue Water Offshore Racing Association, Inc. in its pursuit of a charitable gaming license;

NOW, THEREFORE, BE IT RESOLVED that pursuant to MCL 432.103(k)(ii) the City Council for the City of St. Clair recognizes Blue Water Offshore Racing Association, Inc. as a “service organization” and recommends its approval for a charitable gaming license.
