AN ORDINANCE OF THE CITY OF ST. CLAIR, ST. CLAIR COUNTY, MICHIGAN TO AMEND APPENDIX B OF THE CODE OF ORDINANCES, "ZONING," ARTICLE 4, "ZONING DISTRICT REGULATIONS," SECTION 5, "SCHEDULE OF USE REGULATIONS," SUBSECTION 11 "M-1-LIGHT INDUSTRIAL PERMITTED USES," BY ADDING PARAGRAPH 20 TO INCORPORATE THE ST. CLAIR INDUSTRIAL PARK REGULATIONS INTO THE CITY CODE.

THE CITY OF ST. CLAIR ORDAINS:

SECTION 1. AMENDMENT.

Appendix B, Article 4, Section 4.5.11 of the City's Code of Ordinances, the Zoning

Ordinance, is hereby amended by adding the following paragraph under the heading *Permitted*

Uses:

20. Uses permitted within the St. Clair Industrial Park Land Use Regulations and Site Development Standards pursuant to all regulations governing site and building construction and use. Conflicts between Section 4.5.11(20) and the zoning ordinance are superseded by Section 4.5.11(20).

SECTION 2. SEVERABILITY.

This Ordinance and each of the various parts, sections, subsections, sentences, phrases,

and clauses hereof are declared to be severable. If any part, section, subsection, sentence,

phrase, or clause is determined to be invalid or unenforceable by a court of competent jurisdiction,

it is hereby provided that the remainder of the Ordinance shall not be affected thereby and shall

remain in full force and effect.

SECTION 3. REPEAL OF ORDINANCES IN CONFLICT HEREWITH.

Any and all Ordinances of the City of St. Clair or any parts or provisions thereof, to the extent that they are contrary to or inconsistent with the provisions of the within Ordinance, are hereby expressly repealed.

SECTION 4. RATIFICATION.

All other provisions of the code of Ordinances of the City of St. Clair, Michigan except as herein modified or amended are hereby expressly ratified and affirmed.

SECTION 5. PUBLICATION.

This Ordinance shall be published in accordance with the terms, provisions, and requirements of the City Charter of the city of St. Clair, Michigan, and in accordance with and to the extent required by the statutes of the State of Michigan.

SECITON 6. EFFECTIVE DATE.

This Ordinance shall take immediate effect upon publication in accordance with the

provisions and requirements of the City Charter of the City of St. Clair.
