# ORDINANCES AND RESOLUTIONS

Ordinance Adoption (2021-6) Sewer Ordinance- CITY OF ST. CLAIR, MICHIGAN ORDINANCE NO. 2021-06 SEWER USE AND PRETREATMENT PUBLIC NOTICE is hereby given that Ordinance No. 2021-06 was adopted by the City Council of the City of St. Clair on September 20, 2021 (the "Ordinance"). The Ordinance will take effect on the date of publication in this newspaper. A summary of the Ordinance for publication is set forth below.

The City of St. Clair, a Michigan public corporation established pursuant to the Michigan Home Rule City Act (Act 279, Public Acts of Michigan, 1909, as amended) (the "City"), owns the City of St. Clair Wastewater Treatment Plant ("WWTP"), a wastewater treatment plant that serves the residents and businesses of the City and St. Clair Township through sewer collection systems owned by the City and the Township (the "Collection Systems"). The WWTP and the Collection Systems are collectively referred to as the "POTW."

The City is the designated "Control Authority" for the POTW as provided by the City's National Pollutant Discharge Elimination System ("NPDES") permit and other applicable state and federal pretreatment laws and regulations. As the Control Authority, the City is required to have in place a state-approved sewer use ordinance, implement and enforce a system-wide industrial pretreatment program ("IPP"), independently assess and assure compliance by all persons discharging to the sewer system with applicable laws and regulations, and take other actions as required by those laws and regulations. Ordinance Summary The Ordinance provides the City and the City with the necessary authority and regulatory mechanisms to accomplish the following primary purposes, policies, and objectives in accordance with applicable laws and regulations:

The Ordinance repeals in its entirety existing Article III ("Sewer Service") of Chapter 62

("Utilities") of the City's Code of Ordinances; and adopts a new Article III ("Sewer Use and Pretreatment") of Chapter 62 ("Utilities") of the City's Code of Ordinances.

The Ordinance designates, empowers, and authorizes the City Superintendent to act as the City's principal agent and representative for purposes of administering and enforcing the industrial pretreatment program requirements established by the Ordinance with respect to users or premises that discharge wastewater to the POTW.

The Ordinance sets forth uniform requirements for direct and indirect contributors into the POTW and enables City and the City to comply with all applicable state and federal pretreatment laws and regulations including: the Federal Water Pollution Control Act (also known as the "Clean Water Act"), as amended, 33 USC 1251, et seq.; the General Pretreatment Regulations (40 CFR part 403); Part 31 of Act 451 of the Public Acts of Michigan of 1994, MCLA §§ 324.3101 et seq., as amended ("Water Resources Protection"); and the Michigan industrial pretreatment rules, Michigan Administrative Code, R 323.2301 et seq., as amended.

The Ordinance prohibits the discharge of pollutants into the POTW that do not meet applicable standards and requirements; that would interfere with the operation of the POTW; that would pass through the POTW into the receiving waters or the atmosphere, the environment, or otherwise be incompatible with the POTW: that would inhibit or disrupt the POTW's processing, use, or disposal of sludge, that would cause health or safety problems for POTW workers; or that would result in a violation of the City's NPDES permit or of other applicable laws and regulations.

The Ordinance is intended to improve the opportunity to recycle and reclaim wastewaters and sludges from the POTW, as required by law.

The Ordinance regulates the discharge of wastewater and/or pollutants to the POTW and provides the authority to enforce the requirements of the Ordinance through the issuance of permits and through other means as provided by the Ordinance.

The Ordinance authorizes and requires all inspection, monitoring, reporting and enforcement activities as necessary to ensure compliance with applicable pretreatment standards and requirements and other applicable laws and regulations. The Ordinance provides for the establishment of rates and charges for the installation of, connection to, and use of the POTW for the purpose of recovering the cost of construction, reconstruction, maintenance, repair, operation, depreciation, and replacement of the POTW; providing for such other expenditures and funds for the system as required by the Ordinance; and providing a reasonable rate of return of the City's investment in the POTW. The Ordinance applies to all persons, whether within the City or outside the City, that discharge into the POTW. The Ordinance also applies to any person owning, using, constructing, or maintaining any private system or facility intended or used for the disposal of sewage or wastewater within the City and provides authority to require connection to available public sewers.

The Ordinance makes it unlawful for any person to discharge any wastewater or pollutant to the POTW or to any storm sewer or natural outlet within the City or in any area under the jurisdiction of the City, except in accordance with the provisions of the Ordinance and other applicable laws and regulations. If any user discharges or proposes to discharge wastewaters or pollutants that are prohibited or limited by the Ordinance, the POTW may take any action as provided by the Ordinance or other applicable laws or regulations to assure and require compliance with the provisions of the Ordinance.

The publication of this notice and summary of the Ordinance is intended to meet the requirements for publication as authorized under the provisions of Section 117.3 of the Michigan Codified Laws. No further publication of the Ordinance is required or contemplated. A true and complete copy of the Ordinance can be inspected or obtained at the office of the City Clerk, City of St. Clair, 547 N.
