# CITY OF ST CLAIR, MICHIGAN REGULAR COUNCIL MEETING MINUTES MONDAY, APRIL 17, 2023- 7:00 P.M.

**Meeting Called to Order** at 7:00pm by Mayor Cedar in the Council Chambers of the Municipal Building, 547 N. Carney Drive, St. Clair, Michigan, 48079.

#### **PROCLAMATION**

<u>Proclamation Designating April 28, 2023 as Arbor Day-</u> Mayor Cedar declared April 28, 2023 as Arbor Day in the City of St. Clair.

### **PRESENTATION**

Water Rate Study-Municipal Analytics-John Kaczor, Municipal Analytics, presented the project goals and objectives of the study, introduced new rate setting software, explained operating and capital expenditures, including the current water treatment plant improvements project and how to cover those expenses and customer growth impacts. Township contracts are currently under review and are not part of the model. The current rate schedule is a perfectly acceptable structure for both water and sewer rates however a 3% increase for sewer and a 5% increase for water rates were recommended to cover forecasted usage and operating expenses. Overall, despite substantial new debt service associated with water treatment plant and anticipated sewer treatment plant improvements, those recommended rate increases are modest.

<u>2021--2022</u> Annual Audit Presentation-Maner Costerisan- Jordan Smith, Maner Costerisan, summarized audit findings with a review of revenues, expenditures and current fund balance. Several fThe auditor concluded that all financial statements were presented fairly and in accordance with the applicable financial reporting framework with a clean, unmodified opinion. The city has a healthy fund balance. General Fund, Proprietary funds (sewer, water, harbor) and Debt Service were reviewed. The management letter included proposed journal entries for OPEB and Pensions. The audit was submitted to the state in a timely manner. The full audit is available upon request.

#### ORDINANCES AND RESOLUTIONS

Resolution (23-12) Inches Drain expenditures- AUTHORIZATION FOR EXPENDITURE OF FUNDS IN EXCESS OF STATUTORY MAINTENANCE LIMIT INCHES DRAIN WHEREAS, the St. Clair County Drain Commissioner has advised the City of St. Clair City Council that, pursuant to Section 196 of the Michigan Drain Code (MCL 280.196), an inspection has been made of the Inches Drain and it has been determined, as a result of the inspection, that certain maintenance must be performed upon the drain; and WHEREAS, the Drain Commissioner has the authority to expend Five Thousand and no/100 (\$5000.00) dollars per mile in any one (1) year for the maintenance of the drain, and where it is estimated that expenditures in excess of Five Thousand and no/100 (\$5000.00) dollars per mile are necessary, those amounts may not be expended until approved by Resolution of the governing body of each township, city and village affected by more than twenty (20%) percent of the cost; and WHEREAS, the Drainage Board estimates that the cost of the maintenance of the Inches Drain will be approximately One Hundred Forty-Nine Thousand Nine Hundred and no/100 (\$149,900,00) dollars, which constitutes One Hundred Forty-Four Thousand Nine Hundred and no/100 dollars (\$144,900.00) in excess of the authorized Five Thousand and no/100 (\$5000.00) per mile. NOW, THEREFORE, BE IT RESOLVED that City of St. Clair, pursuant to Section 196(5) of the Drain Code, authorizes the Drain Commissioner to expend funds for the maintenance and repair of the Inches Drain in excess of Five Thousand and no/100 (\$5000.00) dollars per mile for a two year period, to the extent that the drain fund for the Drain contains insufficient funds for the payment of costs incurred for the maintenance or repair of the Drain, the Drain Commissioner is authorized to levy a special assessment, as allowed by law.
