**A RESOLUTION APPROVING THE 2023 TRANSPORTATION ASSET MANAGEMENT PLAN
AND SUBMITTING TO THE TRANSPORTATION ASSET MANAGEMENT COUNCIL FOR
APPROVAL**

WHEREAS, the City of St. Clair in April 2023 re-evaluated the City's roadway network utilizing the Pavement Surface Evaluation Rating or PASER system; and

WHEREAS, the City of St. Clair authorized Anderson, Eckstein and Westrick, Inc, the City's engineering consulting firm to conduct the PASER evaluation and update the City's Transportation Asset Management Plan including a 6-year capital improvement plan prioritizing future roadway improvement projects; and

WHEREAS, the City of St. Clair intends to submit the updated Transportation Asset Management Plan to the Transportation Asset Management Council through the Michigan Department of Transportation for approval, and if approved, would be authorized to transfer additional Act 51 major road funding to the Act 51 local road fund;

NOW, THEREFORE, BE IT RESOLVED, that the City of St. Clair formally adopts the 2023 Transportation Asset Management Plan update and authorizes the submittal of the updated plan to the Transportation Asset Management Council for their review and approval;

BE IT FURTHER RESOLVED, that the City Superintendent, a position currently held by Quentin Bishop, is designated as the authorized representative from the City of St. Clair for all activities associated with the asset management plan referenced above, including the submittal of the document to the Transportation Asset Management Council.
