ORDINANCES AND RESOLUTIONS

Ordinance Adoption (2023-01) Zoning Purpose- AN ORDINANCE OF THE CITY OF ST. CLAIR, ST. CLAIR COUNTY, MICHIGAN TO AMEND APPENDIX B OF THE CITY'S CODE OF ORDINANCES "ZONING," ARTICLE 1 "TITLE, PURPOSE, CONSTRUCTION, RULES APPLYING TO TEXT AND ENABLING AUTHORITY" BY REVISING SECTIONS 1.2 "PURPOSE," 1.3 "CONSTRUCTION," AND 1.6 "ENABLING AUTHORITY." THE CITY OF ST. CLAIR ORDAINS: SECTION 1. **AMENDMENT.** Appendix B, Article 1, Sections 1.2, 1.3, and 1.6 of the City Code of Ordinances is hereby amended to read as follows: APPENDIX B.—ZONING ARTICLE 1.— TITLE, PURPOSE, CONSTRUCTION, RULES APPLYING TO TEXT AND ENABLING AUTHORITY. SECTION 1.2— **PURPOSE.** The purpose of this Ordinance is to regulate the development and use of land; to provide for the adoption of zoning ordinances; to prescribe the powers and duties of certain City officials; to provide for the assessment and collection of fees; and to prescribe penalties and provide remedies pursuant to the authority set forth in Section 1.6. It seeks to promote the public health, safety, and general welfare of the City; protecting the character and stability of neighborhoods; to encourage the use of lands in accordance with their character, relationships, and adaptability; and to limit the improper use of land; to avoid the overcrowding of population; to provide adequate light and air; to lessen congestion on the public roads and streets; to reduce hazards to life and property; to facilitate adequate provision of water supply and sewage disposal, education, recreation, and other public improvements; and to conserve the expenditure of funds for public improvements and services to conform with the most advantageous uses of land, resources, and properties, and with reasonable consideration to the character of each district, its peculiar suitability for particular uses, the

conservation of natural resources, and the general and appropriate trend and character of land, building, and population development, as studied and recommended within the Master Plan adopted by the City's Planning Commission and endorsed by the City Council. The zoning districts and regulations established herein have been constructed in accordance with a general plan for the physical development of the City and its surrounding land area. The City's Master Plan provides thoroughly considered objectives for the sound and orderly development of the City. **SECTION 1.3—CONSTRUCTION.** This Ordinance shall be liberally construed in such manner as to best effectuate its purpose. In interpreting and applying its provisions, this Ordinance's requirements shall establish a minimum basis for the promotion of the public health, safety, convenience, comfort, prosperity and general welfare and shall resolve any conflicts with private restrictions placed on property. Where any condition imposed by any provision of this Ordinance upon the use of any lot, building, or structure is either more restrictive or less restrictive than any comparable condition imposed by any other provision of this Ordinance, or by the provision of an ordinance adopted under any other law, the provision which is more restrictive or which imposes a higher standard or requirement shall govern.

Ordinance Introduction and Adoption (2023-02) DWRSF Authorization of Bonds- AN EMERGENCY ORDINANCE OF THE CITY OF ST. CLAIR TO PROVIDE FOR THE ACQUISITION, CONSTRUCTION, INSTALLATION, FURNISHING AND EQUIPPING OF ADDITIONS AND IMPROVEMENTS TO THE WATER SUPPLY SYSTEM OF THE CITY: TO PROVIDE FOR THE ISSUANCE AND SALE OF JUNIOR LIEN REVENUE BONDS TO PAY THE COST THEREOF; TO PROVIDE FOR THE COLLECTION OF REVENUES FROM THE SYSTEM SUFFICIENT FOR THE PURPOSE OF PAYING THE COSTS OF OPERATION AND MAINTENANCE OF THE SYSTEM AND TO PAY THE PRINCIPAL OF AND INTEREST ON THE BONDS; TO PROVIDE FOR THE SEGREGATION AND DISTRIBUTION OF SYSTEM REVENUES; TO PROVIDE FOR THE RIGHTS OF THE HOLDERS OF THE BONDS IN ENFORCEMENT THEREOF; TO ESTABLISH SEPARATE SERIES OF BONDS OF SENIOR AND SUBORDINATE STATUS WITH RESPECT TO THE NET REVENUES OF THE SYSTEM; TO PRESCRIBE THE FORM OF THE BONDS; AND TO PROVIDE FOR OTHER MATTERS RELATING TO THE BONDS AND THE SYSTEM. THE CITY OF ST. CLAIR ORDAINS: SECTION 1. ENACTING CLAUSE. The following emergency ordinance is adopted under Section 5.10(a) of the City Charter to provide for the acquisition, construction, installation, furnishing, equipping, and financing of additions and improvements to the City's water supply system... SECTION 27. APPROVAL OF BOND DETAILS. The Authorized Officers are each hereby authorized to adjust the final bond details set forth herein to the extent necessary or convenient to complete the transaction authorized herein, and in pursuance of the foregoing is authorized to exercise the authority and make the determinations authorized Officers are each hereby authorized to adjust the final bond details set forth herein to the extent necessary or convenient to complete the transaction authorized herein, and in pursuance of the foregoing is authorized to exercise the authority and make the determinations regarding interest rates, prices, discounts, maturities, principal amounts, denominations, dates of issuance, interest payment dates, redemption rights, the place of delivery and pa

Resolution (23-27) CBH Authorization of Special Assessment - A RESOLUTION CONFIRMING THE ACCURACY OF THE SPECIAL ASSESSMENT ROLL; CONFIRMING THAT THE SPECIAL ASSESSMENTS MADE ARE IN PROPORTION TO THE BENEFITS RECEIVED BY THE PROPERTY OWNERS; AND DIRECTING THE CLERK TO ATTACH

A CERTIFIED COPY OF THIS RESOLUTION TO HER WARRANT COMMANDING THE ASSESSOR TO SPREAD AND THE TREASURER TO COLLECT THE VARIOUS SUMS AND AMOUNTS APPEARING ON THE SPECIAL ASSESSMENT ROLL. A RESOLUTION of the City Council of the City of St. Clair adopted at a regular meeting of said Council held at City Hall located at 547 N. Carney Drive, St. Clair, Michigan, on the 17th day of July, 2023 at 7:00 PM. WHEREAS, the City Council of the City of St. Clair has heretofore determined the necessity of making certain public improvements within the City of St. Clair on Christina B. Haas Drive and part of Jordan Creek Drive, consisting of milling and repaying the roads; and WHEREAS, at the direction of the City Council, the Assessor has prepared, submitted, and reported a Special Assessment Roll wherein the Assessor has included all lots and parcels of land within the area designated benefitting from the public improvement; and has assessed to each lot or parcel of land within the Special Assessment District an equal portion of the total cost of the project on a per parcel basis; and WHEREAS, the City Council has determined that seventy percent (70%) of the total cost of the project, plus all other costs relating to the financing thereof, shall be defrayed and paid for by way of Special Assessment to be spread over and assessed against the properties within the Special Assessment District, and that the remaining cost of said public improvement shall be paid by the City at large; and WHEREAS, the City Council has estimated that the seventy percent (70%) total cost of the public improvement to be borne by property owners within the Special Assessment District was \$232,650.70, plus all other costs relating to financing thereof; and WHEREAS, the City Council has estimated that the thirty percent (30%) total cost of the public improvement to be borne by the City is \$100,000; and WHEREAS, the City Council has previously approved the special assessment roll and the properties contained therein, consisting of the following seven (7) parcels: 74-07-295-0001-000, 74-07-295-0002-000, 74-07-295-0005-000, 74-07-295-0006-000, 74-07-295-0007-000, 74-07-295-0008-000, 74-07-057-0020-000; and WHEREAS, the City Council conducted a public hearing July 17, 2023 at 7:00 p.m. on any objections to the special assessment roll it previously approved and certified as accurate; and WHEREAS, the City Council and the Assessor have resolved any such objections made to the special assessment roll; and WHEREAS, the City Council has determined that the special assessments made therein are in proportion to the benefits received by the property owners; NOW, THEREFORE, it is hereby **RESOLVED** by the City Council of St. Clair, County of St. Clair, State of Michigan, as follows:

- 1. That the City of St. Clair City Council confirms the completeness and accuracy of the special assessment roll prepared by the Assessor;
- 2. That the City of St. Clair City Council is satisfied that the assessments set forth in said Special Assessment Roll are in proportion to the benefits received and derived by the properties specially assessed therein as a result of the public improvements proposed.
- 3. That the City of St. Clair City Council hereby adopts the special assessment roll for the public improvement to be completed pursuant to it.
- 4. That the Special Assessments confirmed herein may be paid in annual installments, between one and 5 years, with the first installment being assessed on the 2023 County (winter) tax bill.
- 5. That the full amount of all or any deferred installments with interest accrued, May be paid in advance of the due dates thereof.
- 6. That deferred installments shall be collected without penalty until sixty (60) days after the due date thereof, at which time such installments shall be considered as delinquent and penalties on said installments shall be collected as are provided by law to be collected on delinquent general city taxes.
- 7. That the Special Assessments and all interests, penalties and charges thereon from the date of confirmation of the Special Assessment Roll shall become a debt to the City of St. Clair from the persons to whom they are assessed and, until paid, such Special Assessments shall be and remain a lien upon the property assessed, of the same character and effect as the lien created by the general law for state, county and

- city taxes and the lands upon which delinquent city taxes constitute a lien.
- 9. That the City Treasurer shall notify by mail each property owner within the Special Assessment District that said Special Assessment Roll has been confirmed by the City Council and filed in the Office of the City Clerk; and the Treasurer shall state to each property owner the amount of the special assessment and the terms of payments; however, the failure on the part of the Treasurer to give such notice or of such property owners to receive such notice shall not invalidate the special assessment thereunder and shall not excuse the payment of interest or penalties.
- 9. That all prior Resolutions and parts of Resolutions of the City Council, insofar as they conflict with this Resolution be, and hereby are, rescinded by the City of St. Clair City Council.
- 10. That the City of St. Clair City Council directs the City Clerk to attach a certified copy of this Resolution to her warrant commanding the Assessor to spread and the Treasurer to collect the various sums and amounts appearing on the special special assessment roll as herein approved.

Resolution (23-28) Award of Water Treatment Plant improvement contract - A RESOLUTION TO TENTATIVELY AWARD CONSTRUCTION CONTRACT FOR WATER Α **IMPROVEMENTS WHEREAS**, the City of St. Clair wishes to construct improvements to its existing water treatment (Water Treatment Plant) and distribution system (Water Main); and WHEREAS, the water system improvements project formally adopted on June 20th, 2022 will be funded through the state of Michigan's Drinking Water State Revolving Fund (DWSRF) program; and WHEREAS, the City of St. Clair has sought and received construction bids for the proposed Water Treatment Plant and water main project and has received a low bid in the amount of \$19,789,000 from Weiss Construction Co. LLC.; and WHEREAS, the City of St. Clair has reviewed the bid price and negotiated a modified project scope reduction in the amount of \$17,039,000 with Weiss Construction Co. LLC.; and WHEREAS, the engineer, Fishbeck has recommended awarding the contract to the low bidder. NOW THEREFORE BE IT RESOLVED, that the City of St. Clair tentatively awards the contract for construction of the proposed Water Treatment Plant and Water Main project in the negotiated amount of \$17,039,000 to Weiss Construction Co. LLC, contingent upon successful financial arrangements with the DWSRF.
