A RESOLUTION FOR THE CERTIFICATION OF ADDITIONAL STREETS TO THE CITY OF ST. CLAIR ACT 51 LOCAL STREET SYSTEM

WHEREAS, the City of St. Clair on December 31, 2023 acquired the streets within the Woodland Estates residential subdivision; and

WHEREAS, it is necessary to furnish certain information to the Michigan Department of Transportation (MDOT) to place these streets within the City of St. Clair local street system for the purpose of obtaining funds under Act 51, P.A. 1951 as amended.

NOW, THEREFORE, BE IT RESOLVED:

1. That the City St. Clair acquires Riley Road and the center line of said street is described as:

Commencing at the intersection of the westerly line of Private Claim No. 305 and the centerline of Vine Street, Town 5 North, Range 16 East, Section 36, thence South 10o-21'-40" West 1,117.41 feet along the west line of Private Claim No. 305, thence along the center line of said street South 79o-27'-19" East 210.00 feet; thence South 10o-21'-40" West 211.60 feet; thence South 79o-27'-19" East 120.00 feet; thence South 10o-21'-40" West 429.98 feet; thence South 79o-27'-19" East 1,051.51 feet; thence northerly along the arc of a curve concave to the east, having a radius of 2,965.84 feet and a chord of 12o-21'-07", 163.70 feet; thence northerly along the arc of a curve concave to the east, having a radius of 2,965.84 feet and a chord of 14o-30'-46", 30.00 feet to the point of beginning; thence, North 75o-29'-14" West 306.61 feet; thence, North 79o-27'-19" West, 371.50 to point of ending.

2. That said street is located within a City of St. Clair right-of-way and is now under the control of the City of St. Clair.
3. That said street is now a public street and is for public street purposes.
4. That said street is accepted into the City of St. Clair local street system and open to public use on December 31, 2023.
