



NOTICE TO RESIDENTS & BUSINESSES

CLINTON AVENUE BIKEWAY PROJECT

THURSDAY, APRIL 11, 2024

As you are aware, the City of St. Clair and the Michigan Department of Transportation has awarded Boddy Construction of Port Huron, Michigan the contract to install a 10 foot wide asphalt bikeway/walking path along the north side of Clinton Avenue from Carney Drive to Riverside Avenue. The City has received grant funding through MDOT's Transportation Alternatives Grant program and through the St. Clair County Community Foundation to complete this project completing a critical gap of the overall master plan for the Bay to Bridge trail network.

Due to this project starting later in the construction season last year, the project was not able to be completed prior to the Winter season. In approximately 2 weeks, Boddy Construction will be returning to the site to continue this project. Weather dependent, it is expected that the project will be nearing completion by the end of May 2024.

Construction Schedule

The work remaining to be completed includes the following:

- Placement of the top course of asphalt for the asphalt pathway that was installed last Fall from Carney Drive to 4th Street
- Installation of concrete handicap ramps at intersections
- Removal of the existing sidewalk and placement of the new asphalt pathway between 4th Street and Riverside Avenue
- Final grading and vegetative restoration of the entire site
- Removal of insufficient retaining walls that were constructed west of 9th Street and modifications constructed

A representative from Anderson, Eckstein and Westrick will be meeting with the residents west of 9th Street prior to work taking place to review the proposed modifications for the replacement of retaining walls and/or modifications to the grading of the site.

Traffic Control and Parking

At no time will Clinton Avenue be completely closed to through traffic. Boddy Construction will have periodic lane closures where work is taking place with flagmen on site to direct traffic around the work zone. In addition, access to 3rd Street, 6th Street and 9th Street will

be open at all times. There may be temporary closures of remaining side streets to complete handicap ramp installations. No parking will be allowed along the north side of Clinton Avenue within the work zone.

Along with the installation of the new bikeway, in order to accommodate the new elevation of the bikeway, all residences along Clinton Avenue will receive a new driveway approach. If you have not had your new driveway approach installed, there will be a period of time when the bikeway and driveway approach in front of your home will be out of service. For residents, it is expected that driveway access would be lost for up to 2 weeks. New concrete placed for driveway approaches requires 5-7 days to cure and reach necessary compressive strength before the driveway can be opened to vehicular traffic. When driveway approaches are removed and replaced, residents will be required to park on the south side of Clinton Avenue, if available or on adjacent side streets. Residents will be notified ahead of time when access to driveways will be temporarily unavailable. Businesses receiving new driveway approaches will be completed half width at a time to allow for continued access throughout the duration of the project.

Irrigation Systems

If you reside or have a business along the north side of Clinton Avenue and have a lawn irrigation system, it is recommended you mark or flag the location of any sprinkler heads located between the street and existing sidewalk or directly behind the existing sidewalk to prevent unnecessary damage to your system. If irrigation systems are accidentally damaged, the Contractor will be required to replace as part of the restoration phase of the project.

Vegetative Restoration

Upon completion of the project, all disturbed lawn areas will be replaced with topsoil and seed. The Contractor will be responsible for establishing vegetative growth.

Garbage Pick-Up/Mail and Parcel Delivery

Garbage pickup, mail delivery and parcel delivery will not be interrupted at any time during this project. For garbage pickup, please place your garbage at the end of your driveway as normal prior to 7am on the day of pickup and the Contractor will move all garbage as necessary for pick up if within the work zone for that day. We recommend that garbage be placed in bags during construction; however, if you do use a trash can, it will be returned by the Contractor. It is recommended that your home address be placed on any trash cans.

We apologize for any inconvenience that this work may cause, but trust that you will understand the benefit of this project once it is completed. We will continue to update you regularly throughout the course of this project with updates delivered to your door.
